

## **Chief Executive Officer Report to the Board January 2020**

## Part 1 Public session

- 1. Our Business Case submission to the Department of Health & Social Care (DHSC) for additional funding this year to help us manage increased workload associated with the Research Systems development and core service provision has resulted in a transitional funding award for the 2020/2021 financial year. This funding is welcomed as it will allow us to continue work on a small number of business-critical projects which will deliver tangible benefits to applicants and staff. This includes work associated with the forthcoming Clinical Trials Regulation e.g. the Combined Ways of Working (CWOW) Project, proportionality work on amendments and student research and a number of strands of priority work in the Transparency Strategy.
- 2. We recently held a planning day to identify the top 5 business priority projects for 2020. This year we asked all directorates and teams to put forward business cases into this process where we would need to allocate resources. This is in addition to a number of other pieces of work that are already in progress e.g. the move to Stratford and the replacement of the ATOS support service. Further work is in train to prioritise the remainder of the business cases but the reality is that we will still have to reduce the amount of activity across the HRA and to invest in projects which release capacity and resources.
- The additional transitional funding for Integrated Research Application System (IRAS) replacement will support the next phase of this work which allows us to develop beyond the minimal viable product for Clinical Trials, to retain expertise and to start planning out IRAS changes associated with Transparency.
- 4. We were disappointed to see a reduction in applicant/customer satisfaction scores over the last reporting period. This appears to be associated with our ability to resolve immediate phone call requests to provide updates on studies due to staff availability. We are currently in the process of developing an action plan to address this, but it is a direct consequence of a reduced establishment.
- 5. We have been continuing to work with colleagues in DHSC to secure funding for the next phase of the IRAS build through an updated business case submission. It had been hoped that we would have completed the revised business case ahead of this board meeting but this has not been possible and we are currently working with the appropriate agency to establish a new timeframe.

- 6. The current phase of the new IRAS build is on track and we aim to deploy the first part of the platform into the live environment to be piloted by a select cohort of researchers by the end of February.
- 7. We have recently procured resources to run a parallel Research Systems workstream within the IRAS build and the Induction process for the team started this week. A new team of additional contractors came on board the week starting 27<sup>th</sup> January and are based in the Skipton House Office which is now close to full occupancy
