Chair's overview of the past year:

2017/18 represented a busy year for the Hampshire B Committee. This year the main Committee has dealt with 47 applications, all within the 60-day time limit. Proportionate Review Sub-Committees dealt with 26 validated applications with two applications exceeding the target of 21 days. Ordinary Sub-Committees dealt with no less than 119 Substantial Amendments with four over 35 days. In addition, the Sub-Committee dealt with seven modified amendments with four exceeding the 14-day target. Whilst the work of the Committee can be assessed only in part in such numerical terms, these figures indicate a continuing commitment to undertaking its review work for the HRA both diligently and efficiently. All contributing members, as well as those backing them up in the South Central office, are to be congratulated on this.

The REC has experienced a number of changes in Membership in the 2017/18 REC year. Dr Andrew Scott decided to retire from the Vice Chair post in July 2017 as did with our pharmacist, Mrs Janet Brember, both after completing 4 years of service. Ms Maisie Gibson also left the Committee in July to relocate for a new job after a year of service. Dr Merriman- Jones agreed to act as Vice Chair and was then successfully appointed at interview in November 2017. In August 2017, we were delighted to welcome a new member in Professor Chris Colbourn, a retired chartered psychologist. At the end of the REC year, Dr Alex Gregory decided not to return to service after a break in service for the birth of his first child.

Dr Sarah Graves has remained our constant, acting as REC Manager to the Committee for this whole REC year. However, she has been supported by four REC assistants during the year, two of whom stayed for very short periods. This has undoubtedly contributed to some communication issues and more studies exceeding the target time lines than the previous year.

I look forward to continuing working with all Committee members and, jointly, contributing to our common undertaking of promoting respect for research volunteers and protecting their well-being and rights.
