

## **HRA Strategy 2022-25 headline priority areas**

### **Where we have come from, where we are heading**

The HRA was established to transform the research regulation and governance sector in the UK. In particular to simplify, streamline and standardise the approvals and set-up of research.

Cast your mind back to 2011 when HRA was first set-up.

Now Picture a cancer patient. Funding has been agreed by Cancer Research UK for a clinical trial relevant to their condition, but they can expect to wait, on average, 621 days for the trial to start recruiting patients. And now think about those patients who might have life expectancies much shorter than 621.

Think about today.

Picture a diabetes patient who juggles a job and caring responsibilities. They've got limited time and energy to engage with their treatment, let alone research.

Picture an elderly relative being well cared for but in a fragmented and hard pushed care setting – with large numbers of informal, voluntary, commercial and public providers.

Picture someone from a community whose needs are so often underrepresented and underserved by public services.

How do we ensure research meets all their needs?

We share a goal with others who work in health and social care research that will require us to work together to achieve it.

Anyone, anywhere in the UK, with any health or care need, from any background, can choose to partner with, get involved in, influence, take part in or learn from research that is relevant to them today. So that research can reduce health inequalities and improve health and social care for all of us tomorrow.

This requires the UK to have a world-leading research sector, providing many different opportunities for people to take part in high-quality, safe, ethical and relevant research.


Fundamental to all of this is trust. Without trust, people won't want to get involved in, participate in, engage with, or use research.
