Chair's overview of the past year:

The Essex REC has had a year of considerable stress, commencing with the reorganisation of the East of England service in which a number of valued members transferred elsewhere, or decided to stand down. The resulting depleted committee, particularly low in expert members, has risen to the challenge of Proportionate Review with the associated short timelines, and has coped with recruitment restrictions. The committee and coordinator are now regularly dealing with amendments and subcommittee work from four now subsumed REC's: Essex 1, 2 and Mid, and Suffolk plus occasional others. This has placed a high workload on a generally willing membership, and will not be sustainable without the recently promised recruitment, to be set alongside the announcement that there is to be a further review and reduction in numbers of REC's. As chair, I am very grateful to the officers, membership and to the coordinator, Suzanne, for their diligence, perseverance and hard work over the past year. We can all look forward to 'interesting times' to come.
