Chair's overview of the past year:

Currently the REC membership runs at 9 expert members and 4 lay members and so is similar in constitution as last year, again I ask NRES to look more closely at its recruitment of members with active recruitment of lay members to committees. The lack of lay members has again meant the committee has found itself non-quorate on a couple of occasions and co-option from other committees had to take place. Attendance by members is generally very good and there is excellent support for the PR applications, with 30 PR reviews taking place over the last year. We as a committee are very pleased with our turn around on these applications although this has added a significant workload to REC members, particularly the chair and vice chair. Ten full ethical review meetings took place between April 2011 and March 2012, with a total of 46 applications being reviewed. This reduction in reviews by full committee is almost certainly a consequence of the PR application process, but it has certainly not reduced the workload of committee members over all, particularly when one considers that the sub-committee (who also reviews the PR applications) has also reviewed 67 substantial amendments and 3 SSAs. It is a concern how this workload might affect other committee chairs/vice chairs and sub-committee members should one of the North West RECs close in the near future, I urge NRES to consider all aspects of a committees role, not just that of 'full ethical review' when considering closing established RECs.

Thank you to all the REC members who give their time for attending meetings and for thorough preparation, which ensures that proper consideration is given to each application. A very big thank you to the staff at Barlow House, to Carol and Laura, who provide excellent support for meetings, sub-committees, communications with applicants and members, and all the many other activities which ensure the research ethics process runs smoothly.
