#### Chair's overview of the past year:

Alan was literally a part of furniture sitting next to researchers at the meeting and giving them useful advice and help in designing their studies and he was equally helpful in giving his opinion on all aspects of the ethical review process. Alan will be sadly missed, and currently Linda Ashcroft is providing extra support to the Committee on statistical issues.

All members old and new are working well together and due to diversity in their work and experience they all bring different dimension in ethical debate. I am grateful to them all. The Vice chair - Tim Sprosen - has changed jobs and moved to Imperial College London and partly abroad to sunny Qatar. We still manage to communicate with him with the modern (may be not so modern) technology of e-mails. Tim provides good overview on data and biobank issues. He also provides training for NRES (HRA) on these issues. We will also be asking him to provide training for the Committee in this area in the near future.

The Co-ordinator - Noel Graham – in addition to his work with the Committee provided additional support to the North West Centre prior to the appointment of the new Centre Manager. We also noted that the Assistant Co-ordinator - Helen Penistone - has moved on to manage another Committee and we appreciate her efforts in ensuring smooth running of the REC. Noel has been provided with additional administrative support following Helen's departure.

After seeing an increase in work load last year, we have noted a drop in research applications.
