Chair's overview of the past year:

This was a rather mixed period, in my view. On the positive side, the Committee quite rapidly became accustomed to reviewing studies involving patients (previously, only Phase 1 trials in healthy volunteers had been reviewed). The Lead Reviewer system was also adopted by the REC and, in most cases, LR reports were available prior to the relevant meeting. Quite large numbers of substantial amendments were reviewed; in part, this was due to the REC acting as successor to PIREC.

On the negative side, several members resigned during the review period, due to a variety of reasons. We were, however, able to recruit some new members and these generally contributed well as soon as they took up their positions. For new studies, our review turn round times (averaging 25 days at the last count; no individual time exceeded the 60 day limit) were close to the general REC norm but were too long, in my view. The fact that we had a number of coordinators in the review period may have been a factor, even though all of them, in my opinion, performed their duties well. It seems likely that the changeover periods may have hindered response speed to some extent. I am hoping that turn round times will become shorter, particularly if researchers can be persuaded to submit their responses in electronic format, whenever possible. Finally, the way in which GafREC is drafted, though generally well intentioned, does sometimes cause practical problems. Only being able to either accept or reject a substantial amendment is an example of this. If the regulations ever come up for revision, I hope that consideration will be given to practical issues.
