Chair's overview of the past year:

The committee's title was changed from 'Hatfield' to 'Cambridgeshire and Hertfordshire' in December 2014 as part of the process to address the low volume of activity of the full committee. From April 2015 through to March 2016 the Committee reviewed 44 applications this was an increase of over 60% from the previous year suggesting that the name change did have an impact. On the other hand the number of applications that involved phase 1 studies remained at a constant but low level. Some members of the committee expressed concern that this may not reflect a proportionate sharing of these applications between flagged committees. Additionally the expertise of these members is not being used to full potential and ways to enhance the number of phase 1 applications need to be considered. Overall of the 44 applications reviewed about 86% were given a provisional opinion. On occasion it proved difficult for the committee to complete its review within the allocated time slot particularly for complex studies. Amendments to the timing of the meeting agenda will be considered in order to help resolve this over the next year. Meetings continued to be held at the University of Hertfordshire and this remained an excellent venue from the perspective of members, applicants and the REC managers.

Sub-committees established to review substantial amendments had 28 meetings in the reporting period. Attempts to achieve a more equitable spread of member involvement and a consequent wider experience for members did have some effect. The influx of new members and the loss of experienced members however means that a greater spread of involvement remains on the agenda for next year. The Proportionate Review sub-committee met 10 times and reviewed 20 applications; for 2 of these applications referral to a full committee was required. Again for this subcommittee the wider involvement of members is part of an ongoing strategy. For both sub-committees on a small number of occasions it was necessary to co-opt members from other RECs.

As a result of interviews three new members were appointed to the committee in the reporting period and they were warmly welcomed. The Committee was very sorry that three members resigned within the year and thanked them each for their valuable contributions that had spanned many years.

The Committee was well supported by the REC Manager and the REC Assistant. The committee received a summary presentation on the new Health Research Authority application process and an introduction to the HARP member portal for electronic access to applications and substantial amendments.
