The year began with the responsibility for the REC being moved from Bristol to Manchester, only a couple of years after the move from the London office. Any concerns about the impact of the move were quickly dispelled, thanks to the planning and care of both Bristol and Manchester REC managers; in fact, it was an almost seamless change. We have welcomed a couple of new members, and we do now have a better balance between expert and lay members. Our very mixed workload provides an interesting diet, particularly with those studies where capacity is lacking, or with prisoners. Sometimes the challenges for these researchers are particularly severe, but Committee members are very positive in their approach, and creative in suggesting routes that might be more ethically appropriate. If we do issue an "Unfavourable" opinion, as far as possible we signpost the manner in which it could proceed.

One problem that continues to cause concern is that of poorly-designed student projects, often aggravated by the failure of the supervisor to attend the meeting. In writing our opinion, we are now explicit in criticizing the supervisor's absence, but that is little comfort to the time-pressured student.

I am grateful to all the REC members for the positive and cheerful atmosphere of the meetings, which includes a friendly and polite approach to researchers, and for the significant sub-committee workload outside of meetings.

Finally, at the end of the year our excellent REC assistant departed; given her skills we were sad, but not surprised, to lose her.
