Chair's overview of the past year:

During the year 2013-4, the continuing reduction in number of full REC applications received overall reflected the changes encompassed in the Harmonised Edition of GAfREC and the introduction of the Proportionate Review System, which is now operating smoothly with the support of the members.

As in the previous year, the Committee took part in shared ethical debate exercises and discussions, and provided feedback to NRES on these.

Members were encouraged to attend appropriate training and provided summaries of these to the remainder of the Committee members, which proved to be most useful. The kind cooperation of the members is reflected in the fact that all members complied with the training requirements.

This year we were joined by Trevor Benn and Clementinah Rooke when GM North was disbanded, but unfortunately Clementinah found the venue difficult to get to and had to discontinue her membership. Trevor has provided invaluable assistance to the Committee particularly in the matter of statistics. The Committee was sorry to receive the resignation of Dr Joshi because of pressure of work near the end of the year following many years of dedicated and constructive work on this Research Ethics Committees, in particular on studies involving psychology/ psychiatry. The REC hopes that NRES will be proactive in the recruitment of new members to return the Committee to a full complement.
