Chair's overview of the past year:

It has been another year of change, sadness and success for the Sunderland Committee. Firstly, it was with great sorrow several members left the Committee after long service, notably Cheryl Anderson who had supported me as Vice Chair since I took over in January 2007. I would also like to thank Sumanto Halder, Karen Horridge and Robert Pullen for all of their services until their retirement from the committee. We were, however, fortunate to welcome John Blenkinsopp, Helen Lucraft and Ross Sayers to the Committee.

Sunderland REC continues its proud tradition of engaging with researchers with its rolling programme of observers attending meetings (six observers attended in this reporting year) and I facilitated another five ethics and consent training days (supported by our Local Research Network).

The work of the Committee continues to remain high quality with no breaches to target and of the 76 (including 26 Proportionate Review) applications, 48 received either a favourable or favourable with conditions decision. Also, despite having a mean average membership of 10 during the year we maintained quoracy at all meetings, with a mean average of 8.7 Members per meeting. Recruiting new Members is ongoing and as always remains a challenge.

Finally, can I thank the Bunny Hill Medical Centre for being our meeting venue as from August 2014 we will be moving to a hotel next to Newcastle Central Station and changing our name to NRES Committee North East - Tyne & Wear South. Many thanks to all who have supported us.
